Elevations were observed on 07-18-2025. The structure slab and block walls. Item C2 b is calculated using the top of the block wall at 17.24' and construction drawings. The Latitude and Longitude were taken in the middle of the front of the residence with a hand held devise. The engineered flood vents will be Smart Vents, Model 1540-520 which are rated at 200 square feet each. 200 times 9 equals 1800 square feet and 1505.5 square feet are required.

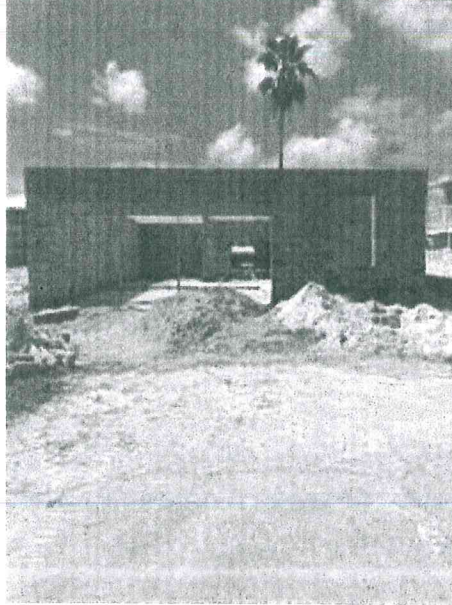

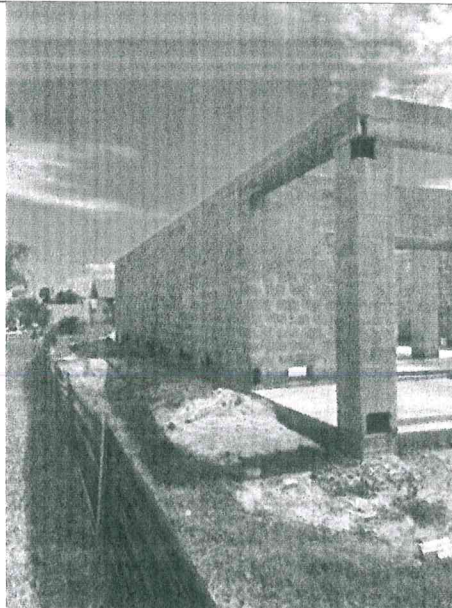

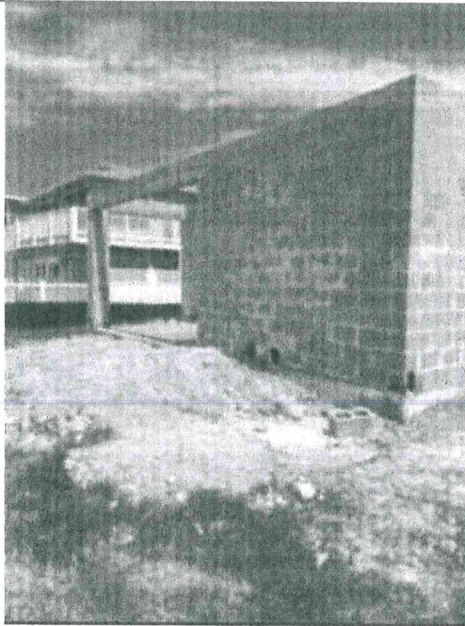
