11 structure that has one (1) to four (4) dwelling units or an individually owned unit in a structure of any size. This also applies to real property that has a combined
12 residential and commercial use. (Section 55-2503, Idaho Code),

13 **PURPOSE OF STATEMENT:** Pursuant to Section 55-2501, Idaho Code, et. seq. the SELLERS of NEWLY CONSTRUCTED residential real property SHALL
