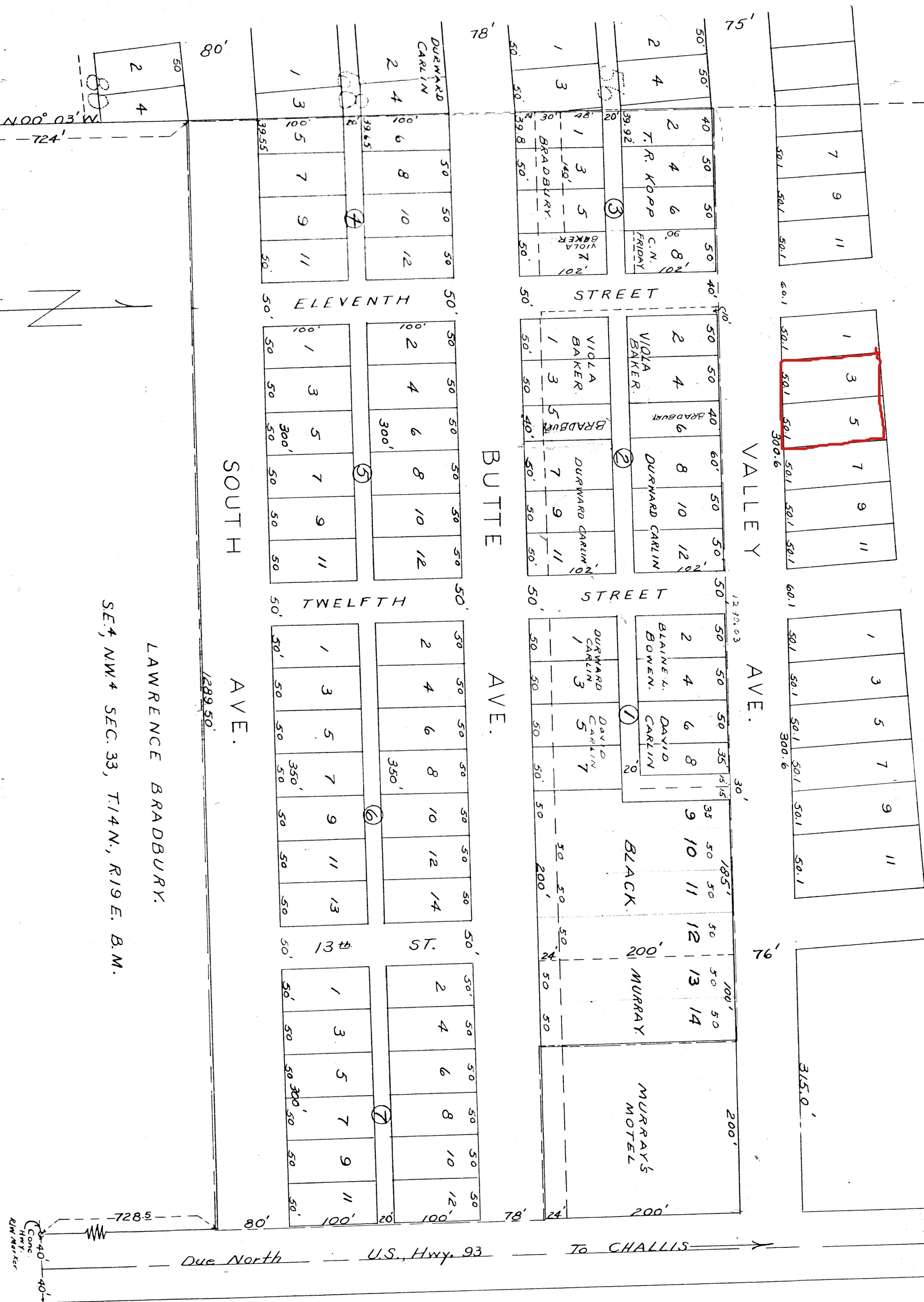


VILLAGE OF CHALLIS
