Roof may have inadequate slope, needs foam rubber gasket replaced, flashing repaired and possibly fasteners replaced in places. Fireplace is sealed and some bricks making up the facade are loose.
Concrete porch shows some cracking. Some of the carport paint is deteriorated. Working smoke detectors are not in all rooms. Central Air may need evaluation/work as temperature split inadequate at inspection.
Water heater is older and should be evaluated plus needs a safety pan installed. Gas line needs to be bonded and vented per inspection. Range does not have anti-tip device.
Exhaust fan in one bathroom terminates in attic rather than outside. Wall heater appears to be inoperable in inspection.
