

Acre Realty, LTD Disclosure Statement

CONTROLLED BUSINESS ARRANGEMENT

This Disclosure Statement made by Acre Realty Ltd – hereafter called “BROKER” discloses BROKER relationship with Valley Title Services of the Fox Valley LLC - hereafter called “VTS”.

In connection with the transaction, the Broker or Broker’s Agents may recommend VTS to provide title insurance or information related to title insurance in a real estate transaction. Because at least one of Broker’s principals (owners) has a financial interest in VTS, Broker must provide the following estimate of the fees and charges that are known by Broker.

The estimated range of charges incurred for Valley Title Services of the Fox Valley, LLC will be:

Mortgage Policy (for Buyer, if required):	\$450-- \$660-
Closing Fee (for Buyer, if required):	\$150.00 - \$400
Title Insurance (Seller):	\$525.00 - \$3,000, may exceed depending on amount of policy
Document Preparation Fee (Seller):	\$150.00 - \$400
Gap Insurance:	\$175.00 - \$300

Only those charges which may be paid by the party(ies) to whom this disclosure is made, are disclosed herein. If there are additional parties who choose to utilize services from VTS, there may be additional charges for those services.

With respect to the fees incurred from the financial services provided, the services provided by VTS may, in part, be the responsibility of the parties involved. However, the seller (or contract of sale) may decide which title insurance services are provided regarding the transaction.

There is no requirement for any party to use VTS as a condition for Broker to provide real estate or brokerage services. There are frequently other settlement service providers available with similar services. Parties are free to compare closing and title service providers before deciding to use title services offered by VTS.

I/we have read this disclosure form and understand that Broker is referring me/us to VTS. Broker may receive financial or other benefit as a result of this referral.

The choice for 3rdPV is solely the responsibility of any Buyer/Seller.
