In consideration of REALTOR® placing a Supra iBox on Owner's Property, Owner agrees that REALTOR®, those working through REALTOR®, REALTORS® who are authorized to use the Supra iBox through NEFAR and the Northeast Florida Multiple Listing Service, Inc., d/b/a realMLS, REALTOR® members, including their licensees and employees, are hereby unconditionally released from liability for any damage, injury or loss to personal property, real property, and personal injury to Owner and any person whomsoever arising out of the use, maintenance or operation of the Supra iBox, and Owner hereby agrees to indemnify and hold all of them harmless therefrom.
